## Homeschool Statement of Cooperation

1. In making an athletic application for my child, it is our desire to have him/her participate in ACA athletics for 20\_\_-20\_\_. We, as parents, agree to accept all regulations for the school on the student's behalf.
2. All students must come from a home where at least one parent or guardian is a professing born-again Christian. We will show sincere Christian purpose by the faithful attendance of our family in church.
3. We shall endeavor to support and uphold the principles, practices, and educational policies of the school in every way. We agree to support the academic standard of Ankeny Christian Academy by providing a quiet place at home for study and by encouraging our child to complete assignments and homework.
4. We agree that if our child should become involved in any difficulty with other children in the school or with any school personnel or if we are concerned with and do not agree with the actions, policies, or decisions of a coach, athletic director or administrator, we will not complain to or discuss these with other parents or students but with a prayerful Christian spirit will register only necessary complaints or concerns with the appropriate school personnel involved in the issue. All parties agree to procedure of conflict resolution within the organization. The Biblical principle for this procedure is found in Matthew 18: 15-17 and I Corinthians 6:1-8.
5. We understand that participation in Ankeny Christian Academy athletics is a privilege and not a right. The school reserves the right to dismiss any student who does not cooperate with the ACA policies and all students are accepted on a probationary basis.
6. There is an athletic registration fee per child, which must accompany the enrollment application form. The registration fee is non-refundable.
7. We agree that the application covers one school year only. Its acceptance is left totally to the discretion of the school and is no guarantee of re-admission in subsequent years.
8. We agree to pay our financial obligation to the school on or before the first day of practice.

9. We give permission for our child to take part in athletics and absolve the school from liability to me or my child because of any injury to my child at school or during any off campus school activity.

10. Since Ankeny Christian Academy cannot care for children who are ill, we agree to come promptly when contacted or make arrangements to have the child picked up if necessary. We also understand that no medication can be administered unless full written instructions accompany such medication.

11. We have read and agree to support the above listed Student Conduct Code. We have read and agree to support and abide by the rules and regulations in the ACA Dress Code Policy. I have discussed the enclosed Student Conduct Code and Dress Code with my student to the appropriateness of my child's age level and maturity realizing that any omission on my part as a parent does not exclude my child from following these codes.
